7.1 Precautions for safe handling

8.2 Exposure controls Provide good ventilation and/or an exhaust system in the work area.

Appropriate engineering controls

Ensure a good ventilation. This can be achieved by local exhaustion or general exhaust air.

Individual protection measures, such as personal protective equipment
